**Canada's \$2.65 billion Climate Commitment:**  
**Climate Finance Projects – Commitments and Disbursements**

**A. Summary:**<sup>1</sup>

Four special Canadian climate funds at MDBs have been adjusted for actual disbursements to final project implementors and for actual adaptation/mitigation allocations according to current disbursements to final project implementors. Two with no known disbursements are considered fully disbursed. (See **Annex Six**)
